

Approved application

The tested AMS is suitable for use at plants according to Directive 2010/75/EC, chapter III (13th BImSchV:2017), chapter IV (17th BImSchV:2013), Directive 2015/2193/EC (44th BImSchV:2019), 30th BImSchV:2017, 27th BImSchV:2013 and TA-Luft:2002. The measured ranges have been selected so as to ensure as broad a field of application as possible.

The suitability of the AMS for this application was assessed on the basis of a laboratory test and a three-months field test at a municipal waste incineration plant.

The AMS is approved for an ambient temperature range of +5° to 40°C.

The notification of suitability of the AMS, performance testing and the uncertainty calculation have been effected on the basis of the regulations applicable at the time of testing. As changes in legal provisions are possible, any potential user should ensure that this AMS is suitable for monitoring the emission limit values and oxygen concentration relevant to the application.

Any potential user should ensure, in consultation with the manufacturer, that this AMS is suitable for the installation at which it will be installed.

Note:

The legal regulations mentioned correspond to the current state of legislation during certification. Each user should, if necessary, in consultation with the competent authority, ensure that this AMS meets the legal requirements for the intended use. In addition, it cannot be ruled out that legal regulations governing the use of a measuring device for emission monitoring may change during the lifetime of the certificate.

Certified product

This certificate applies to automated measurement systems conforming to the following description:

The AMS EL3000-Magnos28 tested here is an extractive AMS and comprises the following parts:

- EL3000-Magnos28 analyser
- Heated probe incl. controller, ABB PFE 3 or PFE2
- Heated sample line (180 °C), (max. 60 m) incl. controller, inner liner made of Teflon
- ABB SCC-F sample pump
- ABB SCC-C sample gas cooler

The Magnos28 analyser is an analyser module integrated in an universal housing type EL3000 which is part of the "EasyLine" series. This housing accommodates the display and control unit, the evaluation unit, the analyser module and the power supply unit. Analogue outputs and data interfaces are also located here.

The housing is available in two different versions.

The EL3020 housing is the 19" version intended for rack mounting.

The EL3040 housing is intended for wall mounting and has a similar size.

Differences between the two versions are limited to the housing. All other components are identical.

General notes

This certificate is based upon the equipment tested. The manufacturer is responsible for ensuring that on-going production complies with the requirements of the EN 15267. The manufacturer is required to maintain an approved quality management system controlling the manufacture of the certified product. Both the product and the quality management systems shall be subject to regular surveillance.
